

#### **Inspect Sewers**

Sewer inspections are part of Virginia Natural Gas' safety practices. If your sewer service is not accessible from the street, Vector Force will make contact with you to coordinate a sewer line inspection from inside your property. There will be no interruption to your natural gas or sewer service during the inspection unless repairs are needed. Vital information from the inspection will be marked on lawns and sidewalks with spraypaint.
