

Virginia Natural Gas Rebate Application

Residential Customers – To Qualify For Your Rebate:

Effective October 1, 2025

1. Applicant must be an active residential gas customer of Virginia Natural Gas.
2. Offer good on purchases for remodeling or renovation of pre-existing homes, condominiums or townhouses. Not applicable to new construction.
3. Application must be submitted online or postmarked within 60 days of purchase and installation of qualifying equipment or by May 31, 2026, whichever comes first. Program subject to annual funding limits, which could cause the program to close early due to fund depletion. Please check the VNG website at virginiannaturalgas.com/residential/ways-to-save/rebates to ensure funding is available at the time of submittal.
4. Receipt or contract invoice must include the date of purchase, model number of installed equipment and proof of payment.
5. Provide a signed and completed application with the invoice or receipt and a photo verifying installation (required for all furnace rebates and all tankless and tank-style rebates).
6. Certain qualifying rebates can opt-in to also receive a free energy-savings kit. Be sure to mark the check box near the signature to request the free energy-savings kit filled with energy savings measures to help you with save energy along with your new appliance.

These program offers are otherwise valid through May 31, 2026, unless suspended by order of the Virginia State Corporation Commission, and while supplies and authorized funding is available. You must provide all the information requested in the rebate claim submission form found on our website at www.virginianaturalgas.com/energyefficiency and deliver supporting documentation as required in order to be eligible, including proof of customer consent to these terms and conditions. Incomplete entries will not be processed and will not be returned. Rebate claim must be submitted using the application provided on our website at www.virginianaturalgas.com/rebates and must be submitted online or postmarked within 60 days of purchase and installation of qualifying product. The furnace must be purchased and installed by May 31, 2026, to be eligible for rebate and must be submitted online or postmarked within 60 days of purchase and installation of qualifying product.

High Efficiency Furnace (90%-94.9% AFUE) \$300 Rebate

Additional Terms and Conditions Rebate applies to residential customers of Virginia Natural Gas who have an active gas account and who are purchasing and installing a natural gas furnace with a 90%-94.9% AFUE. The furnace must be purchased and installed by May 31, 2026, to be eligible for rebate and must be submitted online or postmarked within 60 days of purchase and installation of qualifying product.

High Efficiency Tankless Water Heater (0.95 UEF or greater) \$300 Rebate

The tankless water heater must be purchased and installed by May 31, 2026, to be eligible for rebate and must be submitted online or postmarked within 60 days of purchase and installation of qualifying product.

High Efficiency Tankless Water Heater (0.87 to 0.949 UEF) \$150 Rebate

The above General Terms and Conditions apply to this rebate offer. Additional Terms and Conditions Rebate applies to residential customers of Virginia Natural Gas who have an active gas account and who are purchasing and installing a natural gas tankless water heater with a UEF of 0.87 to 0.949. Maximum rebate value per tankless water heater for this Virginia Natural Gas rebate promotion is \$150. The tankless water heater must be purchased and installed by May 31, 2026, to be eligible for rebate and must be submitted online or postmarked within 60 days of purchase and installation of qualifying product.

High Efficiency Tank-Style Water Heater (0.81 UEF or greater) \$150 Rebate

Additional Terms and Conditions Rebate applies to residential customers of Virginia Natural Gas who have an active gas account and who are purchasing and installing a natural gas tank-style water heater with a 0.81 Energy Factor or greater. Maximum annual rebate value per water heater for this Virginia Natural Gas rebate promotion is \$150. The water heater must be purchased and installed by May 31, 2026, to be eligible for rebate and must be submitted online or postmarked within 60 days of purchase and installation of qualifying product.

High Efficiency Tank-Style Water Heater (0.68 to 0.809 UEF) \$75 Rebate

The above General Terms and Conditions apply to this rebate offer. Additional Terms and Conditions Rebate applies to residential customers of Virginia Natural Gas who have an active gas account and who are purchasing and installing a natural gas tank-style water heater with a 0.68 to 0.809 Energy Factor. Maximum annual rebate value per water heater for this Virginia Natural Gas rebate promotion is \$75. The water heater must be purchased and installed by May 31, 2026, to be eligible for rebate.

High Efficiency Wi-Fi Enabled or "SMART" Thermostat \$50 Rebate

The above General Terms and Conditions apply to this rebate offer. Additional Terms and Conditions Rebate applies to residential customers of Virginia Natural Gas who have an active gas account and who are purchasing and installing a qualifying "SMART" thermostat and natural gas is the main fuel used for space heating in the home. Maximum rebate value per thermostat for this Virginia Natural Gas rebate promotion is \$50. The thermostat must be purchased and installed by May 31, 2026, to be eligible for rebate and must be submitted online or postmarked within 60 days of purchase and installation of qualifying product. Thermostats acquired from the VNG Online Marketplace utilizing rebates provided under the "Limited Rebate Promotion" program are not eligible for this \$50 rebate promotion.
